



Mission Statement

The IECA Foundation was founded in 1996 to support the mission and expand the role of IECA (Independent Educational Consultants Association). The mission of the IECA Foundation is to identify and support programs that have significant impact on underserved students.



2021 MAIN GRANT CYCLE

Educational programs supported by IECA Foundation grantmaking help create opportunities and provide hope to deserving and under-served students. This year, we granted over \$96,000 to 20 organizations spanning 16 states, thanks to incredible support from our donors. These outstanding organizations strive to improve the lives and educational trajectories of students all across the country.

Abramson Scholarship Foundation (Washington, D.C.) \$4,000

The Abramson Scholarship Foundation ensures that motivated, low-income D.C. public high school graduates have the opportunity to get to and through college. They provide students with financial and mentoring resources that help them rise above the obstacles posed by poverty that could otherwise hamper their chances of life successes.



Apparo Academy **A** (Augusta, Georgia) \$5,000

The mission of Apparo is to assist children and their families with the necessary skills to realize their potential and achieve success through educational, nursing, and therapeutic services that are provided in a loving, environment. Apparo Academy offers a full-time, integrated preschool for children with special medical, therapeutic, and educational needs between the ages of 13 months and five years of age. Apparo aims to bridge the gap for children with special needs and provides a safe, therapeutically intensive, inclusion program with speech, feeding, occupational, and physical therapy services provided during the school day; thereby allowing parents the ability to work and provide for their families.

Bay Area Technology School (Oakland, California) \$5,000

The Bay Area Technology School (BayTech), opened its doors in Oakland, California to 78 students in 2004. Sixteen years later, Bay-Tech is now a Western Association of Schools and Colleges accredited, non-profit public charter school with the capacity to serve up to 355 6th-12th grade students, on campus and virtually.



CITYarts (New York, NY) - \$5,000

CITYarts uses arts education, creative projects, and artist-guided collaborative work to educate, empower, and connect youth both locally and around the world. By participating in CITYarts public art projects, students help transform their communities while coming into their own as individuals and as agents of change.

Walking with Justice encourages students at the High School for Law and Public Service to explore the theme of justice as it pertains to law and public service. Ultimately creating a large-scale mural, they will create a new image for their school, realize their potential through the visual arts, and dramatically improve their teamwork, communication, and art skills.

Father's Purpose (Coral Springs, Florida) \$4,500

Father's Purpose is a results-driven mentorship program serving disadvantaged youth and young adults. Founded on the conviction that no life is beyond reach, they organization provides group sessions promoting academic achievement, workforce readiness, accountability, and life principles. Father's Purpose mission: to restore those affected by crime, poverty, and incarceration.

FXB Climate Advocates (New York, NY) \$5,000

FXB is a global social justice organization that works to create a world where everyone has a chance not just to survive, but to thrive. FXB's mission is to provide communities in extreme poverty with the tools they need to become self-sufficient and give their children a brighter future.

Gold Coast Down Syndrome Organization (Boynton Beach, Florida) \$5,000

Gold Coast Down Syndrome Organization is a non-profit dedicated to providing educational and advocacy programs, support, and information to individuals with Down syndrome and their families and raising awareness of the abilities of these individuals.



HOME WORKS! **A** (St. Louis, Missouri) \$5,000

Home Works! (HW!) partners with high-need schools to build their capacity for effectively

engaging parents in their children's learning. HW! trains, supports, and pays teachers to conduct family home visits, and works with schools to implement focused parent engagement strategies at home, with the goal of improving student attendance and school achievement.



Horizons at Sacred Heart University (Fairfield, Connecticut) \$5,000 **A**

Horizons at Sacred Heart University is an out-of-schooltime program that works steadfastly to change the lives of low-income students in Bridgeport, Connecticut. Horizons at Sacred Heart's purpose is to instill a love of learning, teach 21st-century success skills, and empower students to reach their full potential.



Kids on Point **A** (Charleston, South Carolina) \$5,000

Kids On Point introduces young people to the world of opportunity outside of their under-resourced neighborhoods through year-round academic, athletic, and enrichment programming.



LivingWorks (Chicago, Illinois) \$5,000

LivingWorks' mission is to develop the whole person, cultivating within each of its students a desire to learn, and equipping them through mentoring, one-on-one teaching, and play. It accomplishes this mission through quality, affordable after-school and youth mentoring programs by matching each student individually with a tutor/mentor.



Mid-Columbia Reading Foundation (Kennewick, Washington) \$5,000

Mid-Columbia Reading Foundation serves children and families in Benton/Franklin Counties, Washington State. Mission: Encourage and educate families about their important role in raising a reader, support schools in assuring students read at grade level by the end of third grade, facilitate community involvement that ensures young readers are successful.



Missoula Writing Collaborative **A** (Missoula, Montana) - \$3,200

Missoula Writing Collaborative (MWC), is a nonprofit, founded in 1994 to put professional writers in western Montana schools to teach poetry. MWC believes creative writing teaches literary competence, critical thinking, cultural awareness, and artistic joy. MWC has programs in 34 Montana urban, rural, and tribal elementary, middle, and high schools.



Rosati Leadership Academy (Lewiston, Maine) \$5,000

Rosati Leadership Academy (RLA) is a free, after-school, youth-development program for at-risk youth in Lewiston designed to teach life skills, foster character development and leadership potential through soccer. RLA's goals are:

- 1) empowered pro-social and coping behaviors;
- 2) academic achievement;
- 3) soccer development; and
- 4) improved life-circumstances during and after high school.

Serviam Girls Academy (Wilmington, Delaware) \$5,000

Serviam Girls Academy is a tuition-free, private middle school that serves 60-65 under-resourced 5th-8th grade girls in Wilmington, Delaware. Serviam students receive an exceptional, highly differentiated education that focuses on 21stcentury skill development, such as critical thinking, problem-solving, coding, and STEAM preparing them for high school, college, and beyond.



Sisters Circle (Timonium, Maryland) \$5,000

Sisters Circle is a stand-out mentoring program for girls in Baltimore City. Sisters Circle's year-round program model aligns with the Search Institute's Developmental Relationships Framework of expressing care, challeng ing growth, providing support, sharing power, and expanding possibilities — all of which prepare young women to successfully navigate critical life transitions.



Take Stock in Children **A** (Palm Beach County, Florida) \$5,000

Take Stock in Children's mission is to passionately promote selfworth, personal responsibility and academic success for qualified, financially at-risk students throughout Palm Beach County by providing a unique set of resources which includes oneon-one mentoring services, college readiness coaching, college advising, post-secondary retention services, and a guaranteed post-secondary full-tuition college scholarship.



The Leaders Readers Network (Texas) \$5,000

The Leaders Readers Network (formerly Give More HUGS) is dedicated to equalizing access to quality education. Their network of teachers and students represent a diverse and dedicated group of leaders working together to ensure children in their communities have access to brand new books, school supplies, and leadership development.

Trinity Academy of Hartford (Connecticut) \$5,000

In fall 2014, Trinity Academy of Hartford opened its doors as a small independent tuition-free elementary school for low-income students in Greater Hartford. The mission is to educate students in a nurturing and inclusive environment with a focus on intensive academics, the arts, literacy and critical thinking, and to help students to develop the strong core skills needed to grow socially, emotionally and culturally.



UpSpring **A** (Cincinnati, Ohio) \$5,000

UpSpring is the only non-profit exclusively serving the educational needs of children and youth experiencing homelessness in Greater Cincinnati and Northern Kentucky. UpSprings' vision is to positively transform their communities by breaking the cycle of homelessness and poverty. Each year UpSpring empowers the lives of over 4,000 children experiencing homelessness.



2021 MICROGRANTS

The IECA Foundation supports the purpose of every consultant's work — to help children and young adults find the best possible choices for their education. For twenty-five years, the Foundation, the philanthropic arm of IECA, has been funding worthy programs that help children and young adults find great educational opportunities.

Each year, the Foundation seeks to highlight the work that IECA members and consultants do by awarding \$1,000 microgrants to five organizations that align with our mission — organizations where consultants have had an ongoing relationship serving young people as they move forward in their education.

The following organizations are near and dear to the hearts of the IECA members who support them through volunteer work and will receive \$1,000 each from the Foundation:



College Community Career (nominated by Kathy Rose)

CollegeCommunityCareer fosters a college-going culture with lowincome, first-generation high school students and families. They prepare students for admission to and graduation from a four-year university based on these four pillars: College Success, Leadership Development, Civic Engagement, and Career Discovery.





Partners in College Success (nominated by Jennifer Fordham)

Partners in College Success (PiCS) was founded to improve college access, degree completion rates, and early career success for low-income, first-generation students from San Diego County.

High potential first-generation college students are already part of their communities. Challenges they've faced have taught these kids to be courageous and resilient, and to work hard to earn a safe, stable future for their families.

Rainier Scholars (nominated by Lloyd Nimetz)

Rainier Scholars cultivates the academic potential and leadership skills of hard-working, underrepresented students of color.

By creating access to transformative educational and career opportunities and providing comprehensive support to scholars and families, they increase college graduation rates and empower new generations of leaders.

Ridgefield A Better Chance (nominated by Deena Maerowitz)

Their mission is to provide academically talented and highly motivated young women of color from educationally underserved areas the opportunity to live in the community and to study at Ridgefield's public high school. They provide educational, social, and cultural enrichment as they strive to prepare their Scholars to become the leaders of tomorrow.



ScholarMatch (nominated by Dana Roth)

ScholarMatch's mission is to help first-generation college students earn a bachelor's degree within five years. They provide individualized advising, targeted financial support, and career mentoring all the way to graduation.

The Irvin W. Katz Award is presented each year by the IECA Foundation. It was created to honor consultants for their volunteer work with organizations providing educational opportunities to children. Irv Katz was a beloved IECA consultant who worked passionately for the good of children.

This year, the IECA Foundation is delighted to present the Katz Award to IECA Professional Member Antoinette Battiste in recognition of 35 years of community service. Ms. Battiste is the founder and president of Educational Pathways with Antoinette Battiste, a consulting practice that provides college planning and counseling services to high school students and their parents. With an unwavering passion for equity and access in education, she continues active engagement in her community, helping underserved youth break down barriers to educational opportunities through workshops and pro bono services. She received an AB in Psychology and African & African-American Studies from Stanford University and an MBA in Information Systems from Golden Gate University. She also received a Specialized Certificate in College Counseling from UC San Diego Extension.

She is accepting the Katz Award on behalf of the Ivy & Pearls Foundation, the philanthropic arm of the Rho Delta Omega Chapter of Alpha Kappa Alpha Sorority, Inc.






